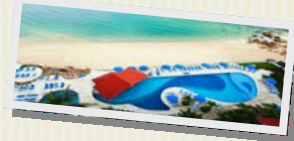


# MEXICO All Inclusive Vacation:

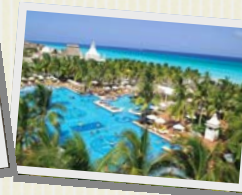

#### NOTE:

- ◆ **All Puerto Vallarta and Cancun accommodations require a Tax & Resort Fee of \$19.95 per night.**
- ◆ In both locations, clients are met at the Airport and taxied to the hotel Free of charge. At the hotel one of our hostesses will meet client assist with check in, and give an orientation for the area.
- ◆ Extra Nights: ~\$100.00 usd per person per night for both locations. (Retail to clients is \$199.00us per night in Cancun or Puerto Vallarta.)
